DSA Employment Process

- 1. **Application**. Complete this application, sign, and submit to dushynsports@gmail.com or to DSA Rhythmic Tumbling Gymnastics and Cheer front desk at address 6333 FM 3180, Ste G, Baytown, TX 77523 (Month Belvieu). Answer all questions as completely as possible. The information you provide on this application will be reviewed to determine your qualifications to move onto the next step in our process.
- 2. **Background Check & Interview**. Based on application review, potential candidates will undergo background and character verification. References will be contacted, and criminal history search will be conducted. Qualified candidates will be contacted for an interview. Be advised that more than one interview session may be conducted and may be performed in person at our facility. We want to ensure that prospective employees are comfortable working with children and will be a good fit in the DSA family.
- 3. **Training Trial for Coaching Positions**. Upon agreement, you will be invited to join and assist some of our classes with our coaches guiding and observing you. It is your responsibility to apply yourself and show us that you are suited for this great responsibility working with children in a safe, fun, and motivating manner.
- 4. **Provisional Employment**. Once you have demonstrated your abilities, and most importantly your positive character, you will be offered provisional employment for up to 90 days. During this time your performance, attendance, and behavior will be carefully monitored by DSA management and coaches. Objectives will be set for your provisional period. Candidates for coaching positions will be required to observe training videos, demonstrate coaching skills, and instruct groups of children. Coaching candidates will be required to obtain the appropriate certifications such as USAG Safety Certification and First Aid Certification during this time. You will be reimbursed for this cost after 6-months of continuous employment with DSA.
- 5. Official Employment. After successful completion of the provisional employment period, you will be given an evaluation to assess your understanding of DSA policies and procedures and the safety and technical aspects of gymnastics. A review meeting will be held with you. Upon satisfactory evaluation and demonstrated compatibility with DSA philosophy and culture, you will be offered official employment.
